- Associate Member: \$500.00 (Non-voting member. These members may not serve on the NAMAD Board of Directors or on NAMAD Committees. Limited only to professional service firms such as law firms, accounting firms and consulting firms.)
- Corporate Members: \$5,000.00 (Non-voting member. These members have no voting rights and are not eligible to serve on the NAMAD Board of Directors. Limited to foreign and domestic corporate entities.)
